

SoulLife Privacy Policy

Very Important – Please read carefully before proceeding with our website.

Thank you for visiting our website (“website”) www.SoulLife.com. As used herein, the terms “SoulLife”, “our,” “we,” and “us” refer to SoulLife LTD. unless the context provides otherwise. We may update this Privacy Policy from time to time without any prior notice to you. We encourage you to review the Privacy Policy periodically for possible revisions.

Introduction: Our Commitment to Privacy

SoulLife™ is committed to protecting the privacy and security of our customers and those who visit our website. To better protect your privacy, we provide this Privacy Policy to explain our practices regarding the information we collect when you visit www.SoulLife.com.

Information SoulLife Collects

Visitors may use our website without registering or submitting any personal information. In this case, we may collect common information as explained below.

We classify all information we collect from visitors to our website as either “Common Information” or “Personal Information”. Common Information refers to information that cannot be traced back to a specific individual. For example, Common Information may include usage statistics such as the total number of visitors to our website during a specific period of time, or the percentage of visitors who use the browser Chrome and how many users prefer the browser FireFox. We use Common Information to improve all visitors’ experience when visiting our website. Personal Information refers to information that is specific to a visitor to our website. For example, Personal Information may include a visitor’s name, address, e-mail address, telephone number and credit card details. Please note that we may gather Common Information without your consent or knowledge, but we may not seek, nor gather Personal Information without your consent.

When visiting our website to order products, make requests, check your account, register to become a member or register to receive materials, we will ask you to provide specific Personal Information. Personal Information means individually identifiable information from or about an individual consumer, including name, home address or billing address, including street name and name of city or town, telephone number, email address and credit card information. This information is voluntarily provided on your part. It allows us to fulfill your order and otherwise operate our business.

We do not automatically collect **Personal Information**. To enhance your visit to our website, we use "Cookies", a standard feature of browser software used by most websites. Cookies are small data files automatically stored on your computer that assist us in serving you. In general, cookies do not contain any **Personally Information** unless you specifically supply the information. We do not use cookies to store **Personal Information**, nor do we link Common

Information stored in cookies with personal data about specific individuals. SoulLife does not collect information about you from other sources, such as public records, other websites or private organizations.

We only collect Personal Information that you specifically volunteer while using our services. Your personal information is confidential and will not be provided to others except as explained in our **Privacy Policy, Terms of Use and Policy & Procedures**.

Use Of Cookies

A “cookie” is a small data file transferred to your computer’s hard drive that allows a website to respond to you as an individual, gathering and remembering information about your preferences in order to customize its operation to your needs, likes and dislikes. Cookies also enable us to keep track of a customer’s electronic “shopping cart” before completing an order. Accepting a cookie does not provide us access to your computer’s files or any Personal Information about you, other than the information you choose to share.

Ordering

When you place an order for products or services, we collect Personal Information (such as name, phone, billing address, credit card, and other transaction information). We use this information to deliver your order, process payment, and to communicate with you about the status of your order. We may provide Personal Information to our partners (such as Postal Outlets and Couriers) when necessary for the delivery of products and processing of your order.

Security

We utilize “SSL” for our website. SSL creates an encrypted bridge between the web server and the web browser (software). This bridge ensures that the data communicated between the web server and the browser remains private and secure for you, the user. Your up-to-date web browser will help you identify secure SSL websites, and websites that are not secure SSL.

Credit Card Storage

Credit card information collected at registration or when placing orders is used only to process payment for the transaction and is not retained by us. You may, however, elect to securely store personal credit card information for use in future orders. You may add, edit, and delete your stored personal credit card information at any time.

Customer

If you are a customer, to assure the highest level of personal service, we may share your Personal Information (excluding credit card information and order details) with your servicing distributor.

Release of Information in Response to Court Order or Subpoena

From time to time, we may provide Personal Information in response to a court order, subpoena, or government investigation. We also reserve the right to report to law enforcement agencies any activities that we believe to be unlawful or suspicious. We may release Personal

Information when we believe that such release is reasonably necessary to enforce or apply our **Terms of Use** or to protect the interests, rights, property, and safety of others and ourselves.

Sharing Your Information

We do not sell, trade, rent, or otherwise profit from any Personal Information we collect online unless we have your permission. Any Personal Information you provide to us will be stored in our databases in the United States, Canada or with our authorized third-party vendors who processes our banking (payment) transactions.

SoulLife may disclose certain information to third-party vendors if necessary to provide you with a product or service your requested and third parties who provide various services to SoulLife and who are required to adhere to the intent of this Privacy Policy.

Protecting Your Information

We acknowledge your trust and are committed to take reasonable steps to protect your Personal Information you provide online from loss, misuse, and unauthorized access. We employ physical, electronic, and managerial processes to safeguard and secure your information.

Links To Other Websites

Links to third-party websites may be provided solely for your information and convenience. If you use these links, you will leave our website. This Privacy Policy does not cover the information practices of those websites linked to our website, nor do we control their content or privacy policies. We suggest that you carefully review the privacy policies and terms of use of each website you visit.

Children's Privacy Protection

We take special care to protect the privacy needs of children. Our website does not target and is not intended for children under the age of 18, and we will not knowingly collect Personal Information from them. You must be at least 18 years old to be a customer.
